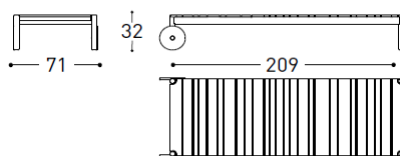

TEAK SUNLOUNGER.
